## TO QUALIFY:

Rank advance to Sapphire and re-qualify 4 times out of 10 months.  
Rank advance to Ruby and re-qualify 3 times out of 10 months.  
Rank advance to Emerald and re-qualify 2 times out of 10 months.  
Rank advance to Diamond and re-qualify 1 time out of 10 months.

Existing Sapphires have to qualify 6 times out of 10.  
Existing Ruby's have to qualify 5 times out of 10.  
Existing Emerald's have to qualify 4 times out of 10.

**For the existing high rank Diamond and Above:**  
Qualify at least 3 times at the rank of Diamond.



## OG GETAWAY 2020 "GIFT" TRIP OVERVIEW

(Independent) Distribution Partners, who meet the qualification criteria listed below, may be offered a OG GETAWAY 2020 5 days and 4 nights "gift" trip to a destination in their respective Regions (Zanzibar/Tanzania, Fujian/China, Antalya/Turkey, Cuba, Hawaii) organized by Organo Gold Holdings, Limited.

The program qualification period is between September 1, 2019 to June 30, 2020 (10 months). Only participants who have met the criteria contained herein will be considered for the OG GETAWAY 2020 "gift" trip.

If a (Independent) Distribution Partner qualifies he/ she is responsible for filling and submitting the Credit Card Billing Authorization Form to [recognition@organogold.com](mailto:recognition@organogold.com). This form will be kept on file until 15 days after the conclusion of the OG GETAWAY 2020 "gift" trip.
14. If a (Independent) Distribution Partner decides to cancel the trip, cancellations must be in writing via email on or before July 31, 2020. Otherwise, a cancellation/no-show fee of \$400 may be charged to the Credit Card Billing Authorization Form submitted by the qualifier to compensate losses of Organo Gold Holdings, Limited related to the cancellation.
