

TERMS AND CONDITIONS FOR PORTUGAL INCENTIVE 2024

1. INTRODUCTION:

We are excited to offer our top-performing Distribution Partners (DPs) an exclusive opportunity to qualify for an all-inclusive hotel stay in beautiful Portugal. This incentive aims to reward your hard work and dedication with an enriching and memorable experience. Alternatively, qualified DPs can choose to receive a monetary reward. Read on to find out how you can qualify and the terms and conditions that apply.

2. QUALIFICATION PERIOD:

The qualification period for the Portugal incentive runs from the 27th of May until the 23rd of June 2024.

3. ELIGIBILITY:

- All DPs are eligible to participate. However, those who have already qualified for the Getaway programme are only eligible for the monetary compensation and cannot qualify for the trip to Portugal.
- DPs must meet the specified qualification criteria set by ORGANO.

4. QUALIFICATION REQUIREMENTS:

- DPs must achieve one of the following requirements:
 - a) Sponsor 5 new DPs with a PSP (Advanced or Boundless) or a promo pack (April Madness, April Sugar-free, or May promo pack);
 - b) Generate 4000 PV in personal and retail sales;
 - c) Rank advance to Platinum Elite (10000 GQV) or above;
 - d) Sponsor 2 new DPs with a PSP (Advanced or Boundless) or promo pack (April Madness, April Sugar-free, or May promo pack) AND generate 2000 PV in personal and retail sales.
- Additionally, DPs must be a Star Achiever in both May and June.
- DPs must maintain compliance with ORGANO's policies and procedures throughout the qualification period.
- DPs must demonstrate ethical business practices and maintain good standing with ORGANO.

5. REWARDS:

- The first 3 DPs who qualify will be selected for an all-inclusive hotel stay in Portugal from 3rd to 7th July, 2024. Selection will be based on revenue generated, type of qualification, and total volumes.
- All other qualifying DPs will receive a monetary compensation of \$900 loaded into their OGPAY account.

6. SELECTION CRITERIA:

- Among DPs who meet the qualification requirements, the company will select the 3 DPs who have generated the highest revenue during the qualification period.
- If multiple DPs have met the qualification requirements for the trip to Portugal, the selection will be based on total revenue generated during the qualification period, highest number of PSP or promo packs sponsored, highest PV generated.

7. NOTIFICATION:

- DPs who believe they have qualified must notify ORGANO's customer service as soon as possible by emailing europe@organogold.com. ORGANO will not track individual qualifications.
- If one of the qualification pathways is chosen that requires the sponsorship of new DPs, the qualifier must provide the name and ID of these new DPs so that the qualification can be validated.
- It is the responsibility of the DPs to ensure their qualification is reported to ORGANO within the specified timeframe.

8. TRAVEL EXPENSES:

- The all-inclusive hotel stay covers accommodation, meals, and select activities organised by ORGANO during the specified dates.
- Travel expenses, including flights to and from Portugal, are the responsibility of the DP.
- ORGANO only covers the accommodation costs for the DP; if the DP chooses to bring an additional guest, he/she can stay in the same room at no extra cost, but the guest will have to pay for an

all-inclusive meal plan (130 EUR per night).
