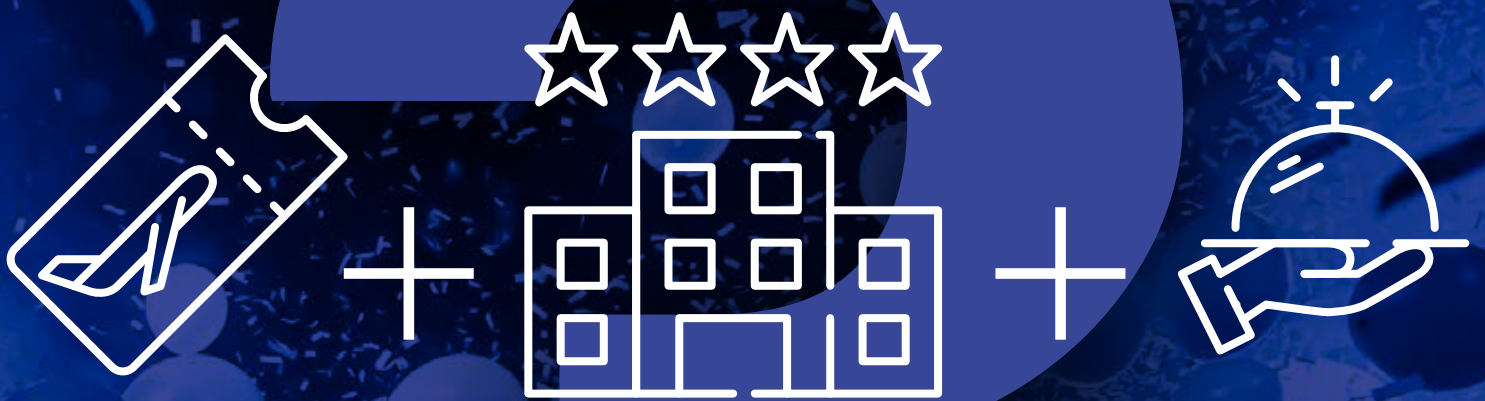

Terms and Conditions of the Summer Incentive for ORGANO's The Future Is Now Roadshow

Overview:

These Terms and Conditions ("Terms") apply to the Summer Incentive for the ORGANO's The Future Is Now Roadshow ("Incentive") organised by ORGANO. By participating in the Incentive, all participants ("Distribution Partners") agree to be bound by these Terms.

Incentive Duration: The Incentive qualification period runs from June 3rd to September 30th.

Levels and Prizes:

Level 1 - Prize: Flight refund up to 1000 USD

To qualify for Level 1, Distribution Partners must achieve one of the following criteria during the qualification period:

1. Sponsor six new Distribution Partners with an Advantage, Boundless, or medium promotional pack. The new Distribution Partners must remain active with at least 100 PV per month during the qualification period.
2. Generate 1000 PV per month in personal and retail sales.
3. Rank advance to Platinum Elite (10000 GQV) and re-qualify for at least one month during the qualification period. Distribution Partners with a lifetime rank of Sapphire and above must re-qualify for at least one month as their rank or rank advance.

In addition to the above, Distribution Partners must also be a Star Achiever every month during the qualification period.

To qualify for Level 2, Distribution Partners must achieve one of the following criteria during the qualification period:

3. Rank advance to Platinum Elite or above (10000 GQV) and re-qualify for at least two months during the qualification period. Distribution Partners with a lifetime rank of Sapphire and above must re-qualify for at least two months as their rank or rank advance.

In addition to the above, Distribution Partners must also be a Star Achiever every month during the qualification period.

To qualify for Level 3, Distribution Partners must achieve one of the following criteria during the qualification period:

1. Sponsor ten new Distribution Partners with an Advantage, Boundless, or medium promotional pack. The new Distribution Partners must remain active with at least 100 PV per month during the qualification period.
2. Generate 1400 PV per month in personal and retail sales.
3. Rank advance to Platinum Elite or above (10000 GQV) and re-qualify for at least three months during the qualification period. Distribution Partners with a lifetime rank of Sapphire and above must re-qualify for at least three months as their rank or rank advance.

In addition to the above, Distribution Partners must also be a Star Achiever every month during the qualification period.

General Terms

1. Eligibility: This Incentive is open to all Distribution Partners of ORGANO who meet the qualification criteria outlined above.

2. Verification: All qualifications are subject to verification by ORGANO.

ORGANO reserves the right to disqualify any Distribution Partner who does not meet the criteria or who is not in good standing with the company.

3. Qualification Notification: It is the responsibility of Distribution Partners to monitor their qualification status and notify the ORGANO Support Team (at Europe@organogold.com) of their qualification status when the qualification period is about to close. Distribution Partners, in fact, must send an email to ORGANO informing of their possible qualification. ORGANO will then check and, if they are qualified, confirm it by sending an email to their registered email address to confirm their qualification achieved. Qualified Distribution Partners must confirm acceptance of the prize within 7 days of notification; failure to do so may result in forfeiture of the prize. It is the qualified Distribution Partner's

responsibility to check their email, including the spam folder.

ORGANO is not responsible for any missed communications.

Additionally, ORGANO may announce the qualified Distribution Partners on its official website and social media platforms.

4. Prize Redemption:

- Prizes will be awarded after the qualification period has ended and qualifications have been verified.

- Prizes are non-transferable and cannot be exchanged for cash or other alternatives.

- Distribution Partners will be responsible for any applicable taxes or fees associated with the prizes.

- In the case of travel prizes, if the prize includes accommodations, only the Distribution Partner's stay is covered; any accompanying persons must pay for their own accommodations. Any alcohol, additional meals, or personal expenses are not included in the prize and must be paid for by the Distribution Partner.

- Prizes must be accepted as awarded within 7 days of notification. If a Distribution Partner is unable or unwilling to accept a prize, the prize will be forfeited.

- ORGANO reserves the right to substitute any prize with another of equivalent value without giving notice. Prizes must be utilised within the specified period; any unused portions of the prizes will be forfeited.

- ORGANO is not responsible for any travel disruptions or cancellations that may affect the prize.

- Distribution Partners are responsible for obtaining any necessary travel documents, such as visas and passports.

- ORGANO will not organise any travel arrangements but will reimburse the cost of the flight up to 1000€. Qualified Distribution Partners must send proof of purchase and travel details to ORGANO to receive reimbursement.

- ORGANO will endeavour to provide top-quality accommodation according to its own standards, focusing on comfort, position and overall guest satisfaction. However, specific details such as hotel category, location, or room type cannot be guaranteed or requested. ORGANO selects accommodations based on criteria including guest reviews, available amenities, and the overall quality of the accommodation.

5. Modification and Termination: ORGANO reserves the right to modify or terminate this Incentive at any time without prior notice. Any changes will be communicated to Distribution Partners promptly.

6. Governing Law: These Terms shall be governed by and construed in accordance with the laws of the country in which the Distribution Partner resides and has engaged with ORGANO, without regard to its conflict of law principles.

7. Liability: ORGANO shall not be liable for any direct, indirect, incidental, special, or consequential damages arising out of or relating to the Incentive or these Terms.

8. Force Majeure: ORGANO shall not be responsible for any failure to fulfil its obligations under this Incentive due to causes beyond its control, including but not limited to acts of God, war, and natural disasters.

9. Data Protection: By participating in the Incentive, Distribution Partners consent to the processing of their personal data by ORGANO for the purposes of administering the Incentive. ORGANO will process such data in accordance with its Privacy Policy.

Additionally, by participating, Distribution Partners consent to ORGANO using their names, images, and likenesses in promotional materials on official ORGANO platforms, including websites and social media, in compliance with European data protection laws.

10. Compliance with Laws: Distribution Partners are responsible for ensuring that their participation in the Incentive complies with all applicable laws and regulations, including but not limited to tax laws and regulations.
